DIVISIONS- There will be three scratch divisions: U20 Boys, U20 Girls, & U15 Mixed.

FORMAT- Everyone will bowl 6 games qualifying at 9:00 am. The field will then be cut to the top 6 in each division for 6 games of Round Robin Match Play. After Match Play the top 3 bowlers will advance to the stepladder finals. (#3 Seed vs. #2 Seed / Winner vs. #1 Seed)

ENTRY- The entry fee is \$50 per bowler. Pre-Registration is not required but is strongly suggested. You may Pre-Register thru Facebook, Tournament Director Contact, or Email Contact.

PRIZE FUND- 1:5 Bowlers will cash. If youth bowler places, their earnings will be awarded in scholarship money through USBC S.M.A.R.T. Account #11469. The Prize List will be posted on site and is based on the number of entries. Adults will be offered scholarships or cash.

DRESS CODE- All bowlers are required to wear collared shirts and slacks. Skirts, skorts, and shorts will be permitted for ladies.
